Dear Sir/Madam,

As a Distributor or Converter of our products, it is our responsible duty to inform you of the following in relation to the REACH Legislation.

In accordance to article 33 of the Reach regulation, any supplier of an article containing a recognised substance of very high concern, in a concentration above 0,1% (w/w), where there is a foreseeable risk of exposure to that substance, shall provide the recipient with sufficient information to allow safe use of the article including as a minimum, the name of the substance.
